## McClellan Announces Transition of Technical Review Committee to Restoration Advisory Board

*The public is invited to attend a special public meeting on the transition of the Technical Review Committee to the Restoration Advisory Board on Wednesday, September 14th at 7:00 pm at the Bell Avenue School. Please see page 2 for more information.*

The Department of Defense (DoD) is expanding the public's role in the Installation Restoration Program (IRP) and environmental cleanup at McClellan Air Force Base. To allow for this, McClellan is increasing the public's role by expanding the Technical Review Committee (TRC) to the Restoration Advisory Board (RAB). RAB members will include community members to reflect the diverse interests within the local community.

As part of the IRP, McClellan is continuing to address cleanup of groundwater and soil contamination. McClellan is also looking at innovative technologies to allow for faster cleanup using more cost-effective measures.

### *What is a Restoration Advisory Board (RAB)?*

The RAB is an advisory board designed to act as a focal point for the exchange of information between local community members, McClellan, The United States Environmental Protection Agency (US EPA), and the California Environmental Protection Agency Department of Toxics Substance Control (Cal/EPA-DTSC) and the Regional Water Quality Control Board (RWQCB). The RAB is intended to bring together community members who reflect diverse interests within the local community, enabling early and continued two-way exchange of information, concerns, values, and needs between the affected communities, the state and federal regulatory agencies and McClellan Air Force Base. The RAB will work in partnership with McClellan and the regulatory agencies on cleanup issues and related matters throughout the entire environmental cleanup.

RAB members will meet regularly to review and comment on technical documents and plans relating to the ongoing environmental studies and cleanup activities at

McClellan. RAB members will be expected to serve as a liaison with the community and be available to meet with community members and groups. Membership terms will be decided by the RAB. All RAB meetings are open to the public. Technical information and administrative support will be provided to the RAB by McClellan.

### *How to Become a RAB Member*

Community members interested in finding out more about the RAB are invited and encouraged to attend a community meeting conducted by McClellan at the Bell Avenue School (please see map on back of this factsheet) on September 14, 1994 at 7:00 pm. At the meeting, we will discuss the purpose of the RAB, membership opportunities and member expectations. RAB membership applications will be available at the community meeting. 


